Terms and Conditions for Manjushree Debit Card

- 1. The Manjushree Finance Limited debit card (card) is the property of the Manjushree Finance Limited at all the times.
- 2. The Card is non-transferable.
- 3. If the information submitted by the card holder is found to be false and/or the card has been misused, the Manjushree reserves the right to seize/cancel the card issued to any card holder.
- 4. The Manjushree shall debit the Account(s), designated by the Cardholder for all the transactions initiated including cash withdrawals by using the card. For this purpose, the card holder irrevocably authorize the Bank to debit his/her Nominated Account(s) with the amount of the transaction(s) effected through the use of the card.
- 5. The Manjushree shall debit the nominated account(s) for all the fees and charges as determined by the Manjushree relating to the card and the services thereby provided.
- 6. The case of joint Nominated Account(s), all the members shall be jointly and severally be responsible for all the transactions performed on card.
- 7. The Manjushree reserves the right to terminate membership, withdraw the privileges attached to the card or not renew the expired card at any time and to call upon the cardholder to surrender the card.
- 8. Use of the card after notice of withdrawal of the privileges of the termination of the membership is fraudulent and may be subject to legal action by the Manjushree in accordance with the prevailing law.
- 9. Upon termination of membership or withdrawal of privileges of the card for any reason whatsoever, the card shall be returned to the concerned branch within 7 days from the date of receipt of notice. The card holder shall be liable for payment of the bills arising out of use of the card till card is not surrendered to the Manjushree.
- 10. The cardholder shall provide written instructions to the Manjushree for the cancellation/non-renewal of the card one month prior to the expiry date specified in the card.
- 11. The card and personal identification number (PIN) issued to the card holder are entirely at the cardholder's risk and responsibility. The Card holder shall not disclose the PIN or permit possession of the card to any other person. The card holder undertakes full responsibility for any and all the transactions made by the use of the card whether or not made with his/her knowledge or authority.
- 12. The Card holder agrees to inform Manjushree in written regarding lost/stolen, damage of the card and disclosure of PIN. The Card holder will be held liable for all the transactions receiver prior to this notification.
- 13. The Manjushree reserves the rights to limit daily transaction including cash withdrawal and purchase by the card holder and decide on the denomination that would be dispensed from Manjushree's own Automated Teller Machine (ATM).
- 14. The Manjushree shall not be responsible in any way for non-availability of services from ATM or Point of Sale terminals (POS) at Merchant outlets for any reason what so over and howsoever arising as a result of malfunction of the card or ATM or POS, insufficiency of funds in such machines, mechanical or power supply failure or otherwise.
- 15. Any dispute related with the transaction performed through card must be notified to Manjushree within 30 days of transaction for processing chargeback.
- 16. It is card holder's responsibility to check the statement from time to time to confirm correctness of transactions.
- 17. The Card holder under takes to indemnify the Manjushree indemnified against all losses, cost or expenses incurred and sustained by the Manjushree arising out of cardholder's failure to observe any terms and conditions herein mentioned.
- 18. The card holder will be liable for any kind of violation of foreign currency rules and regulations.
- 19. The card holder is restricted to use card for payment of expenditure.
- 20. On demand by the Manjushree, the card holder should submit necessary details, bills or invoice in relation to the payment made through POS for the purchase of goods and services.
- 21. The Manjushree reserves the right to restrict the card transaction or provide details of the card holder to Nepal Rastra Bank for necessary action in case the card holder fails to comply with the terms and conditions in relation to transaction.
- 22. The Manjushree reserves the right to amend these terms and conditions along with fees and charges without prior notice to the card holder and such amendments shall be binding to the card holder.
- 23. All disputes are subject to the jurisdiction of courts in Kathmandu, Nepal.
