## Terms and Conditions for Manjushree Mobile Banking Service

- 1. Mobile banking service is exclusively for the use by the customer authorized to do so by bank. It is not transferable. It should not be used for any purpose other than the transactions designated by the bank. The customer must maintain an account at a branch of the bank to use the service.
- 2. The customer should keep the User ID/Password/Personal Identification Number (PIN) provided by the bank strictly confidential and undertake not to reveal the code/ID number to any person at any time under any circumstances.
- 3. The customer should keep the bank informed immediately upon becoming aware that the user ID/Password/PIN is lost or has fallen into the hands or notice of any unauthorized person and the customer should request the Manjushree to block/cancel the PIN/ password and change it.
- 4. The customer should accept full responsibility for all the transactions processed from the use of mobile banking service provided by the Manjushree.
- Manjushree is not bound to carry out the instructions given through mobile banking service, if the Manjushree at its sole discretion believes that such instruction is not emanated from the customer.
- 6. The Manjushree has the authority to debt the account with the amount of any Withdrawal / Transfer/ Payment made by the use of mobile banking service provided by the Manjushree.
- 7. Commission and/or service charge shall be levied by the Manjushree as applicable. The account(s) shall be subject to the applicable charges as per the Manjushree's schedule of charges as revised from time to time. The Manjushree shall always be entitled to recover any charges, expenses, fees, commission, markup, and penalties, withholding taxes levied by the Government Department or authorities with or without notice to the customer. Manjushree is also entitled to reverse entries mad e in error.
- 8. Manjushree shall not be liable, responsible or accountable in any way whatsoever arising by any malfunction or failure of the electronic devices/system or on the failure or delay on the Manjushree to act the instructions given via this non-acceptance of instructions given on mobile banking service.
- 9. At no time should the customer use or attempt to use the mobile banking service to execute transfer of funds, unless sufficient funds are available in the account. The Manjushree is under no obligation to honor any payment instructions unless there are sufficient fund in designated account(s) at the time if receiving such payment instructions.
- 10. The customer shall accept the Manjushree's record of transactions as conclusive and binding for all purposes.
- 11. The use of mobile banking service shall be subject to the Manjushree's prevailing rules and regulations.
- 12. Manjushree shall at any time be entitled to amend, supplement or vary any of these terms and conditions and fees and charges applicable as its absolute discretion with or without notice to the customer and such amendment, supplement or variation shall be binding to the customer.
- 13. Unless required or requested by law or any government body, information pertaining to service to the customer or customer's account will be kept confidential.
- 14. The request or application of the customer for the mobile banking service shall be subject to the approval of the Manjushree. Manjushree shall be entitled as its sole discretion to reject this application or any part thereof, without furnishing any reasons.
- 15. The Manjushree shall have the full discretion to cancel, withdraw or renew the mobile banking service provided to the customer with or without prior notice or any reasons given to the customer.
